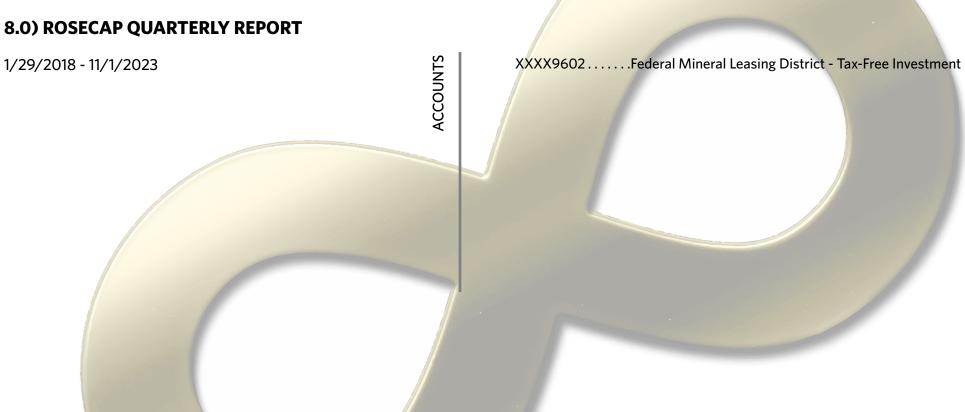

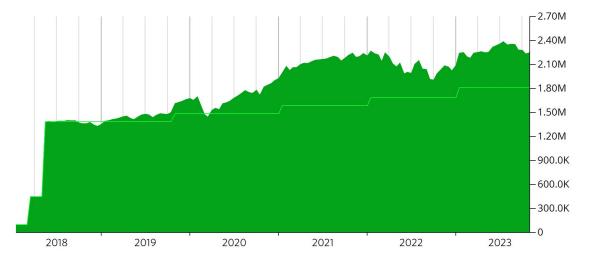

Allocation by Asset Class

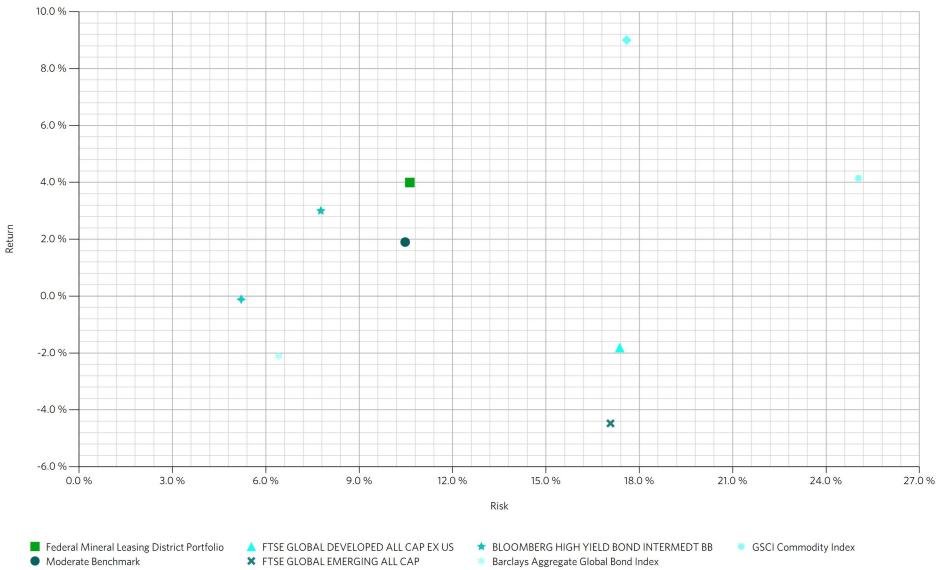

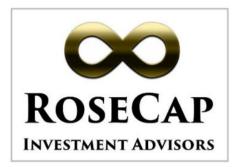
