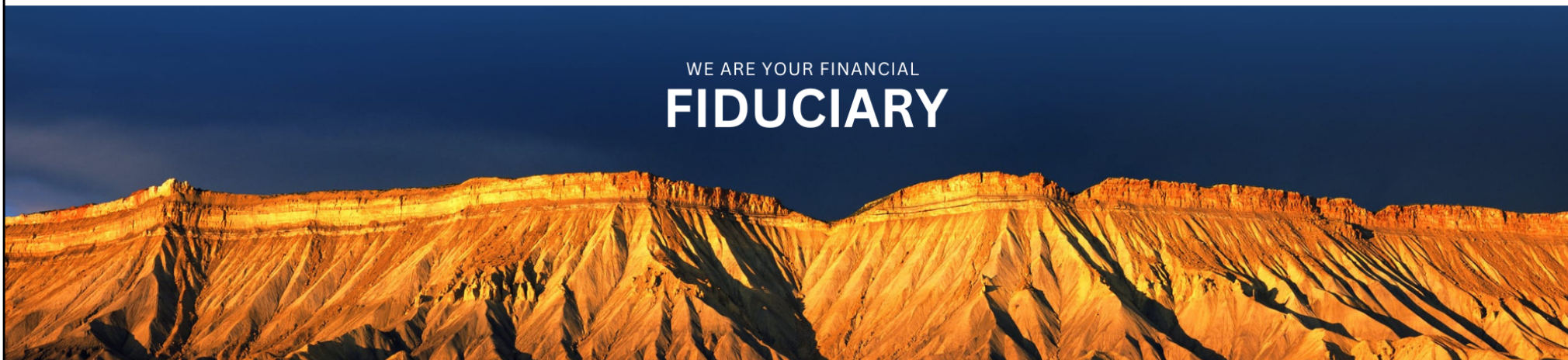

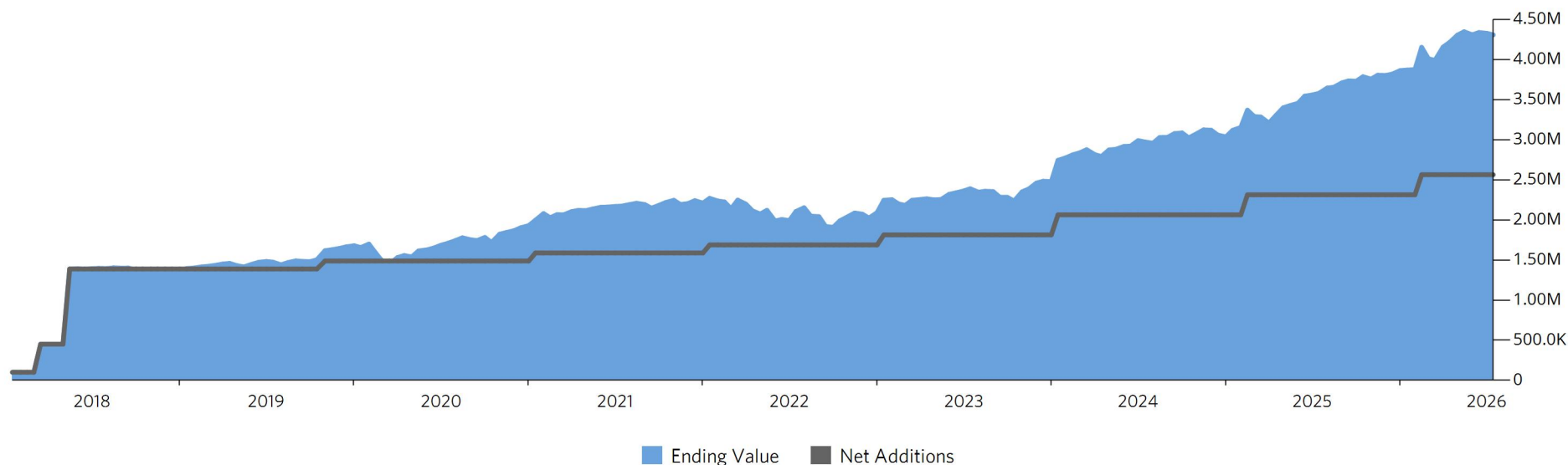

Market Value Since Inception

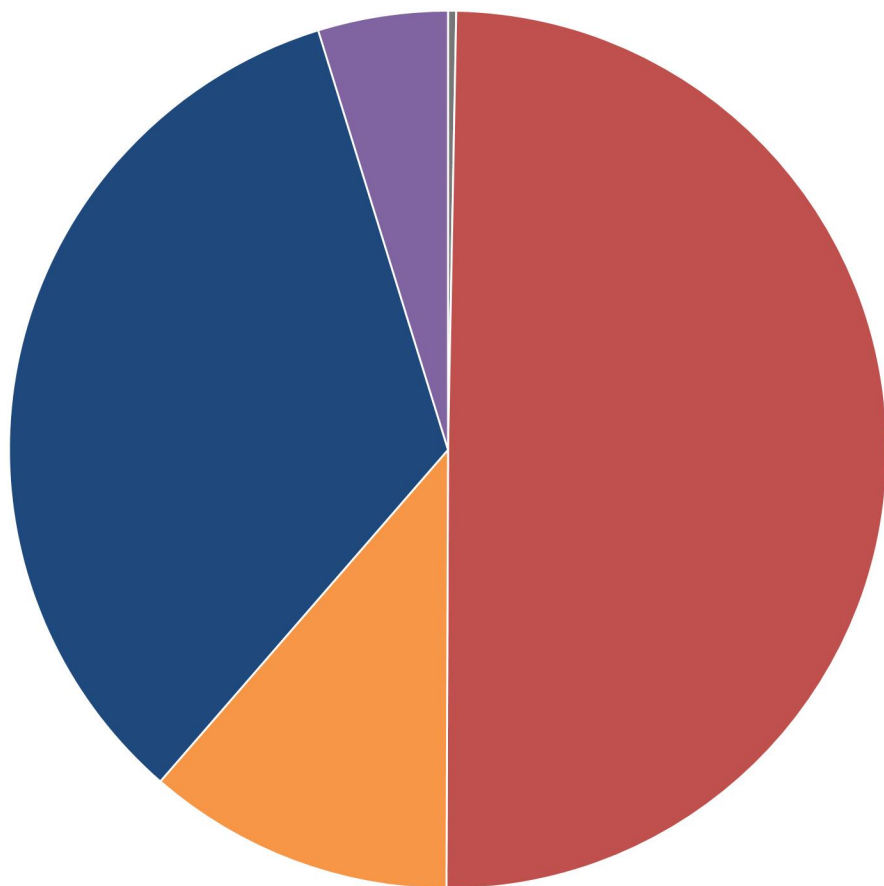

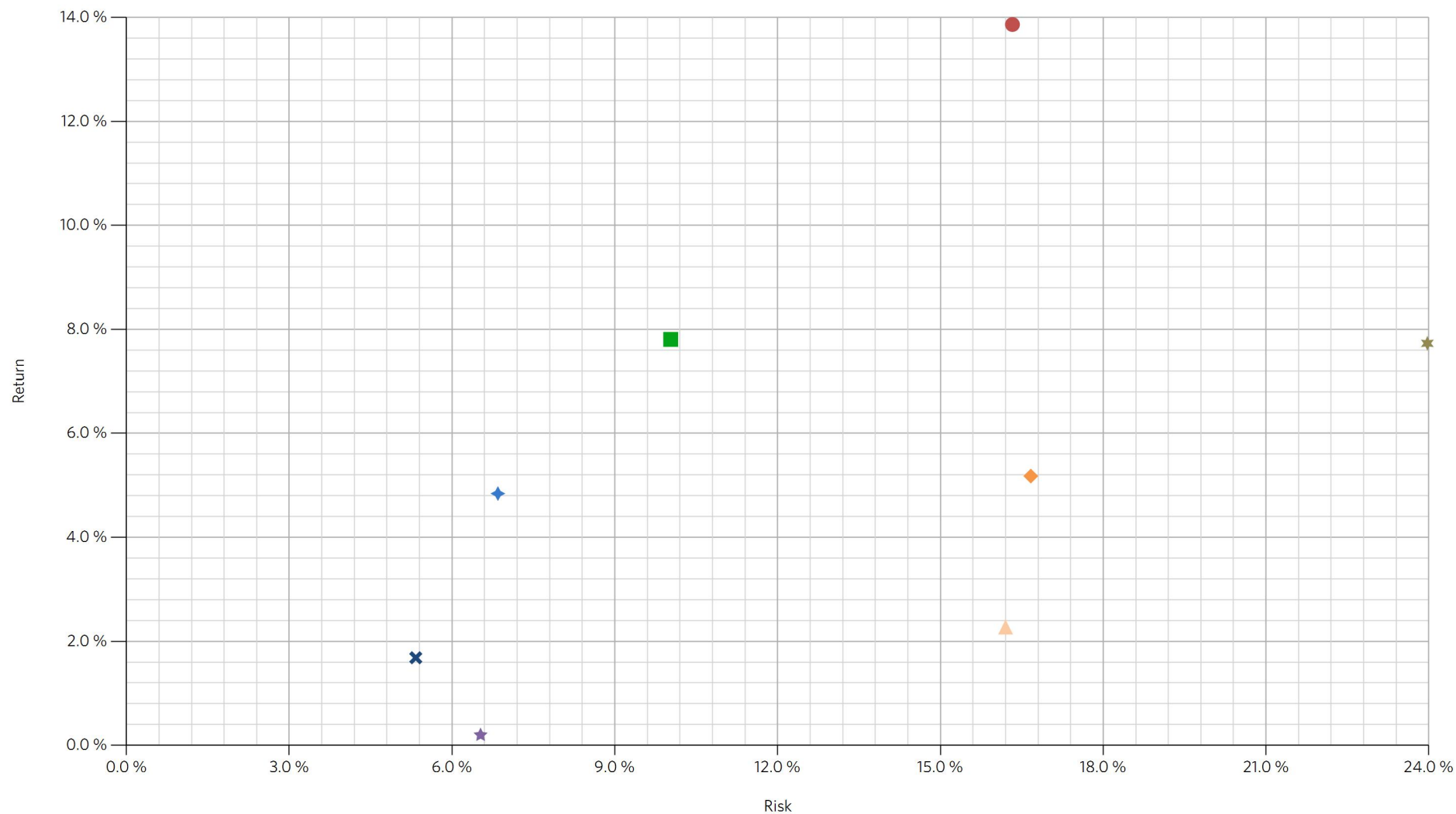
